

Dear Board Members:

Eagle Mountain City has long been known as a diverse and fast-growing community in Utah County. One of our well-established missions is to maximize preservation of open space throughout the City. The General Plan and Municipal Code include provisions to protect and preserve the many natural features and places important to wildlife and to watersheds.

Tickville Gulch is an important wildlife corridor and recreation area in the City. We continually make efforts toward the conservation and management of the gulch, however, through misuse over the years, the wash has become degraded and needs restoration in many places. This wash provides major drainage into Utah Lake which benefits not only water quality, but also supplies invasive weed management around the lake.

City employees are working with the Utah Department of Agriculture and Food, and the Utah Division of Wildlife Resources to prepare a project with Utah's Water Shed Restoration Initiative (WRI) to install beaver dam analogs (BDA) in several key areas. As we work near Camp Williams, we will also include partners from the West Traverse Sentinel Landscape Program as defined in State code.

The City continues its commitment to the management and care of Tickville Gulch. As this project begins, we are looking for opportunities to maximize City funding with any match from other agencies, whether directly or with in-kind support. Any additional funding and resources that our State partners/agencies can provide toward implementing these conservation measures would be most appreciated.
