**A RESOLUTION OF EAGLE MOUNTAIN CITY, UTAH, RECOGNIZING  
THE PONY EXPRESS EVENTS PRCA RODEO AND DEMOLITION DERBY  
AS PART OF THE OFFICIAL PONY EXPRESS DAYS CELEBRATION**

*PREAMBLE*

WHEREAS, the first Pony Express Days Rodeo was held in 2010 in Eagle Mountain City, Utah, to commemorate the 150<sup>th</sup> anniversary of the Pony Express riders who carried mail across the western United States; and

WHEREAS, Pony Express Events entered into an agreement with Eagle Mountain City in 2014 to lease the rodeo grounds and host an annual rodeo and other community events; and

WHEREAS, the rodeo and demolition derby have continued to be an annual community event, managed by Pony Express Events, concurrent with Eagle Mountain City's annual Pony Express Days celebration; and

WHEREAS, the rodeo and demolition derby have an annual attendance of approximately 7,500 people consisting of both residents and visitors; and

WHEREAS, the rodeo has been nominated several times and was awarded "Best Rodeo of the Year" in its state and category by the PRCA Wilderness Circuit in 2023 and 2020; and

WHEREAS, recognizing the rodeo and demolition derby as being part of the annual Pony Express Days celebration will show continued support for the events and entertainment opportunity for Eagle Mountain residents and visitors to the City.


