

RESOLUTION NO. R-57- 2025

A RESOLUTION OF EAGLE MOUNTAIN CITY, UTAH, SUBMITTING AN OPINION QUESTION TO THE CITY'S REGISTERED VOTERS AT THE NOVEMBER 4, 2025 MUNICIPAL GENERAL ELECTION REGARDING AUTHORIZATION TO IMPOSE A ONE-TENTH OF ONE PERCENT (0.1%) SALES AND USE TAX FOR RECREATION, ARTS, AND PARKS ("RAP TAX"); APPROVING THE BALLOT TITLE AND PROPOSITION LANGUAGE; AND RELATED MATTERS.

WHEREAS, Utah Code Ann. §§ 59-12-1401 through 1403 authorize a city to submit an opinion question to its residents on whether the city should impose a 0.1% local sales and use tax to fund botanical, cultural, recreational, and zoological organizations and facilities; and

WHEREAS, before submitting such an opinion question, a city must comply with the prerequisites and notice requirements set forth in § 59-12-1402, including coordination with the county and election officials; and

WHEREAS, the City Council desires to submit the RAP tax opinion question at the November 4, 2025 Municipal General Election and to approve the ballot title and proposition language attached as Exhibit A.

NOW, THEREFORE, BE IT RESOLVED by the City Council of Eagle Mountain City, Utah, as follows:

Section 1. Submission of Opinion Question. The City Council hereby submits to the registered voters of Eagle Mountain City, at the November 4, 2025 Municipal General Election, the opinion question of whether the City should impose a 0.1% sales and use tax to fund botanical, cultural, recreational, and zoological organizations and facilities within the City, as permitted by Utah Code Ann. § 59-12-1402.

Section 2. Ballot Title and Proposition Language. The ballot title and proposition language in substantially the form attached as Exhibit A are approved. The City Recorder, in consultation with the City Attorney, is authorized to make non-substantive edits required by the Utah County Clerk, the Lieutenant Governor, or applicable law.

Section 3. Statutory Prerequisites; Coordination. The City affirms compliance with Utah Code Ann. § 59-12-1402, including providing the required written statement to the Utah County legislative body and confirming that Utah County does not impose, and does not intend to submit for imposition, a county RAP tax under § 59-12-703 for the 2025 election cycle. The City Recorder is directed to: (a) transmit this Resolution and Exhibit A to the Utah County Clerk within the timeframes


required by law; (b) coordinate election administration and ballot printing; and (c) publish and post all required notices.

Section 4. Severability. If any provision of this Resolution is declared invalid, the remaining provisions shall continue in full force and effect.

Section 5. Effective Date. This Resolution takes effect immediately upon adoption.


