NOTICE OF PUBLIC HEARINGS

The Eagle Mountain City Council will hold public hearings on **August 18, 2026, at 7:00 PM** or as soon thereafter as business allows, in the Eagle Mountain City Council Chambers, 1650 E Stagecoach Run, Eagle Mountain, Utah 84005. The City Council will receive public comments concerning the following items:

Adoption of the Final Budget for FY 2026-2027:

- **Adoption of the Final Budget for FY 2026-2027:** The City Council is considering adoption of the Fiscal Year 2026-2027 final budget following completion of the Truth-in-Taxation process. The final budget includes an increase to the property tax rate and will generate additional revenue to support public safety.

The City Council reviewed the proposed Property Tax Impact Schedule on May 5, 2026, adopted the Fiscal Year 2026-2027 Interim Budget on June 16, 2026, and held a Truth-in-Taxation public hearing on August 6, 2026, to receive public comment regarding the proposed property tax increase and its impact on property owners. The final budget will be the document that governs the expenditures for Fiscal Year 2026-2027.
